The Board of Trustees of the Sheet Metal Workers' Local No. 73 Welfare Fund Plan A for Active Members is pleased to announce a new benefit improvement.

ENHANCED DENTAL BENEFIT

We are pleased to announce the Plan is improving the dental benefit for all Plan A Active Members effective July 1, 2019. Under the new dental benefit design, the Plan will pay for services according to the following schedule:

Calendar Year Deductible (per person)	\$25	\$25
Preventive Services	No charge	No charge
Basic Services	20% coinsurance	20% coinsurance
Major Services	50% coinsurance	50% coinsurance
Orthodontia Services (to age 19)	50% coinsurance	50% coinsurance
Calendar Year Maximum (per person)	\$1,750	\$2,000
Orthodontic Lifetime Maximum	\$1,500	\$2,000
Coverage for Sealants (under preventive services)	No	Yes
Coverage for Implants (under major services)	No	Yes

Statement of Grandfathered Status

The Board of Trustees believes that the Plan is a “grandfathered health plan” under the Affordable Care Act, which means that our Plan existed when the health care reform law was signed on March 23, 2010, and that we can preserve certain basic health coverage that was already in effect when the law was passed. However, as with all grandfathered health plans, we must still comply with certain consumer protections in the Affordable Care Act (for example, the elimination of the Plan’s lifetime maximum). Consequently, because this Plan is “grandfathered” and not required to adopt other changes required by the Affordable Care Act, this Plan may not include certain consumer protections of the Affordable Care Act that apply to other plans.
