SUMMARY ANNUAL REPORT FOR **SHEET METAL WORKERS' LOCAL 73 WELFARE FUND**

This is a summary of the annual report for Sheet Metal Workers' Local 73 Welfare Fund EIN 36-2145881, for the year ended June 30, 2025. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$88,966,458 as of June 30, 2025 compared to \$95,834,481 as of July 1, 2024. During the plan year, the plan experienced a decrease in its net assets of \$6,868,023. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$65,526,055 including (but not limited to) employer contributions of \$49,233,736, participant contributions of \$3,840,337, other contributions of \$49,442, realized gain of \$199,993 from the sale of assets and earnings from investments of \$8,205,180.

Plan expenses were \$72,394,078. These expenses included \$3,954,916 in administrative expenses and \$68,439,162 in benefits paid to participants and beneficiaries.

transactions in excess of 5 percent of plan assets.

If you request a copy of the full annual report from the plan administrative manager, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 4530 Roosevelt Road, Hillside, IL 60162 and the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
